- <u>6 Secretary's Report</u> Owing to a family crisis, Michael Hennin was unable to deliver his report. It is appended below.
- 7 Treasurer's Report After an introduction from Robin Coxon the statement of the Association's accounts for the year to 31 December 2009 was adopted having been proposed by Eric Pask and seconded by Ann Coffey. It was unanimously agreed that the annual subscription should remain at £10 proposed by David Patrick, seconded by Hilary Bailey. The Honorary Auditor was unanimously re-elected proposed by Robin Coxon, seconded by Michael Coffey.
- <u>8 Election of Officers</u> Simon Williams (President), Michael Hennin (Secretary) and Robin Coxon (Treasurer) stood for re-election, proposed by Michael Coffey, seconded by Hilary Bailey. They were re-elected unanimously.
- <u>Properties</u> 9 <u>Election of Committee</u> Dr Andrew Pink has resigned from the committee. Rosemary Knight was elected to serve a second term. Following earlier cooption to the committee, Lilian Gibbens was elected to serve a first term. Ted Sharp was elected to serve a first term. All were proposed by Michael Coffey, seconded by Hilary Bailey and were unanimously elected. Terence Atkins continues his 2nd term; Roger Carter and Susan Dingle continue their 1st term:
- 10 Adopting the New Constitution Simon Williams introduced the proposed changes to the existing Constitution previously circulated to all members and noted a few final amendments. Under the terms of the constitution 2/3rds of the membership must be in favour of any proposed change. The Association currently has 75 members. At the meeting all 20 members present voted to adopt the revised constitution, proposed by Eric Pask and seconded by Terence Atkins. 24 proxy votes were also cast in favour by Simon Williams and Robin Coxon, giving a total of 44 votes in favour, leaving the resolution six votes short of the required number. In view of the fact that only six further votes were needed and since all votes so far received were in favour it was agreed

that, should the remaining votes be secured within one week, then the revised constitution could be adopted. When passed, a copy of the new constitution will be circulated to all members. It will also be available on the EDOA website. [Post meeting note – the six required votes were duly received within one week.]

Terence Atkins organised two events – the rewarding-looking trip to play organs in Cambridge (alas, there were insufficient takers to make it worthwhile), and a visit to the Felix Aprahamian house, where members were welcomed by EDOA member David Aprahamian Liddle. Michael organised the Members' recital last June at EDOA member Rev'd James Spanner's church and is planning a choral event in the autumn to be led by our last president, Andrew Parnell. Lilian is co-ordinating my talk on organ repertoire and Robin is organising this year's members' recital, both of which take place in the summer.

I am also grateful for the work of our Teachers' Forum under Roger's chairmanship. This year we have their Students' Recital to look forward to. Finally, I would like to thank Paul Minchinton on your behalf for his work on the newsletter.
